One-Div

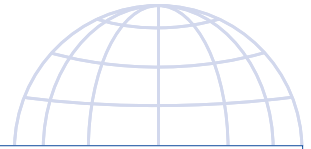
An online query generator which provides a tax reclaim calculator for one dividend event.

Multi-Div

Provides the same result table as One-Div but permits a query of up to ten dividend events per beneficial owner type/residency combination. The screen also contains a downloadable spreadsheet for larger portfolios and a 5-day turnaround free analysis service via email.

Position

Position allows a subscriber to populate a spreadsheet with position data such as the number of shares, security identifier(s), beneficial owner type and residency. GlobeTax will calculate the withholding tax position of the beneficial owner(s) based on the portfolio as of the last known pay date.
